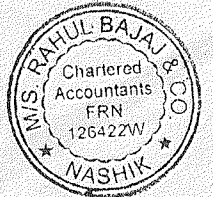
1. Rs. 35290.60 was brought forward foreign contribution at the beginning of the financial year.

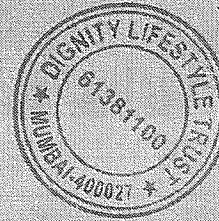
